## (a) Finance Report for May

The report is attached.

Expenditure for the month was £9,781, which is about the expected average monthly spend for the year.

Bank balances at the end of the month were:

Interest of £40 was received into Reserves at the beginning of June.

The accountants have produced the Annual Accounts for 2024/25, showing an overall loss of £47, which means that no Corporation Tax will be payable for that year.

#### Enter and View visits

- The reports on visits to the St George's Hub and the associated GP practice have been drafted. The report on the main hub has been cleared; comments are awaited on the report about the GP practice.
- Arrangements for the visit to Maylands GP practice and to Spa Medica Eye Clinic are in hand. The follow ups to Greenwood GP

practice and A&E at Queen's will be arranged, probably for late June or early July.

#### Defibrillators in Havering

 The initial survey of defibrillator locations is complete and the report is in hand.

## • Survey of Same Day Access Hubs (GP Hubs) users

 The survey was launched at the beginning of June and will close on 30 June.

## Safe Surgeries

Safe Surgeries is an initiative by NHSNEL aiming to improve the safety of surgeries for patients who are homeless or from minority backgrounds. It is known that many practices across North East London (including in Havering) are failing to comply with NHS contract requirements relating to the registration of patients, including continuing to demand proof of address before taking a patient on, which is contrary to NHS expectations.

It is proposed to carry out a "mystery shopping" exercise across North East London to identify which practices are compliant. Further details are awaited.
