The Freedom of Information Act 2000 (FOIA) gives rights of public access to recorded information held by public authorities. The FOIA is intended to promote a culture of openness and accountability among public sector bodies, and therefore facilitate a better understanding of how public authorities carry out their duties; make decisions and spend public money.

Healthwatch Havering Healthwatch is subject to the FOI Act as a public authority and has a duty to comply.

Anyone has a right to request information from a public authority. Healthwatch Havering has two separate duties when responding to these requests:

- to tell the applicant whether we hold any information falling within the scope of their request; and
- to provide that information

Healthwatch Havering uses its website

<u>www.healthwatchhavering.co.uk</u> - as the principal means of disseminating information about itself and its activities. In most cases this information can be located using the 'search' facility.

### We routinely publish information:

1. Who we are and what we do

Organisational information, structures, locations and contacts.

## 2. What we spend and how we spend it

Financial information relating to projected and actual income and expenditure, procurement, contracts and financial audit.

We publish annual financial statements in our Annual Reports and a monthly summary report is published on our website.

### Information that we will not generally make available

- Information in draft form
- Information which would be impractical or resource intensive to prepare for routine release
- Information which is no longer readily available because it is archived or its retrieval would be difficult, impractical or resource intensive to prepare for routine release
- Information whose release is prohibited by law or which is exempt under the FOIA or is otherwise considered to be



protected from disclosure (for example, personal data relating to any individual).

If the information you need is not on our website, you can also contact us to request information under the Freedom of Information Act.

Healthwatch Havering works to 20-working days to respond to a request. If we are unable to achieve the 20 working days response time, we will advise the applicant as soon as possible and seek a reasonable extension to the 20-working day timeline.

If you are unhappy with the response you received from us relating to your FOIA request please let us know, giving your reasons. We will respond to you in writing.

## Duties related to Healthwatch Havering (Provider) to the London Borough of Havering (Authority)

Relating to the contract with the London Borough of Havering

Healthwatch Havering (Provider) and the London Borough of Havering (Authority) acknowledge their respective duties under the FOIA and must give all reasonable assistance to each other where appropriate or necessary to comply with such duties in relation to information held by Healthwatch Havering that has been provided by the Authority in connection with its statutory duties.

- that the Contract and any other recorded information held by the Provider on the Authority's behalf for the purposes of the Contract are subject to the obligations and commitments of the Authority under the FOIA;
- that the decision on whether any exemption to the general obligations of public access to information applies to any request for information received under the FOIA is a decision solely for the Authority;
- ➤ that if the Provider receives a request for information under the FOIA, it will not respond
- ➤ that the Authority, acting in accordance with the codes of practice issued and revised from time to time under both section 45 of the FOIA, and regulation 16 of the Environmental Information Regulations 2004, may disclose information concerning the Provider and the Contract either without

consulting with the Provider, or following consultation with the Provider and having taken its views into account; and

- ➤ to assist the Authority in responding to a request for information, by processing information or environmental information (as the same are defined in the FOIA) in accordance with a records management system that complies with all applicable records management recommendations and codes of conduct issued under section 46 of the FOIA, and providing copies of all information requested by a Authority within 5 Business Days of such request and without charge.
- that the Contract and any other recorded information held by the Provider on the Authority's behalf for the purposes of the Contract are subject to the obligations and commitments of the Authority under the FOIA



### What is Healthwatch Havering?

Healthwatch Havering is the local consumer champion for both health and social care in the London Borough of Havering. Our aim is to give local citizens and communities a stronger voice to influence and challenge how health and social care services are provided for all individuals locally.

We are an independent organisation, established by the Health and Social Care Act 2012, and employ our own staff and involve lay people/volunteers so that we can become the influential and effective voice of the public.

Healthwatch Havering is a Community Interest Company Limited by Guarantee, managed by three part-time directors, including the Chairman and the Company Secretary, supported by two part-time staff, and by volunteers, both from professional health and social care backgrounds and lay people who have an interest in health or social care issues.

Following the public inquiry into the failings at Mid-Staffordshire Hospital, the Francis report reinforced the importance of the voices of patients and their relatives within the health and social care system.

Healthwatch England is the national organisation which enables the collective views of the people who use NHS and social services to influence national policy, advice and guidance.

Healthwatch Havering is <u>your</u> local organisation, enabling you on behalf of yourself, your family and your friends to ensure views and concerns about the local health and social services are understood.

<u>Your</u> contribution is vital in helping to build a picture of where services are doing well and where they need to be improved. This will help and support the Clinical Commissioning Groups, NHS Services and contractors, and the Local Authority to make sure their services really are designed to meet citizens' needs.
